NCBTMB, in a letter signed by its board of directors and sent to FSMTB's board of directors on Aug. 24, which was provided to MESSAGE Magazine by NCBTMB, rejected the proposal, stating in part, "Regrettably, it appears clear that FSMTB's original intent for this collaboration has changed. Therefore, we are not comfortable proceeding with a collaborative program under the current demands and potential implications for the profession."
